GLOBAL METHODIST CHURCH

Pros

- Kent Island been a Methodist church
 maintains historic Methodist
 tradition
- A denomination traditional leadership team that we know and trust
- An organizational structure that we know
- A Doctrine & Discipline that we know and believe (Wesleyan doctrine and theology based on Scripture)
- Leaner, more effective denominational structure (less apportionments)
- More resources for local ministries & prioritizing the work of the local church
- No Trust Clause- church owns property
- Accountability at all levels to include Bishops
- Biblical stances on social issues however, denominational statements will require greater consensus (75% agreement rather than 51%)
- Local involvement in pastoral appointments
- Connectional partnerships with denominational partners on local, national and global scene
- Shorter route to ordination for clergy
- Opportunity to build a new denomination
- Disaffiliation from GMC is quick, simple and without cost

Con

- New Denomination with uncertainty; under transitional leadership and doctrine until first General Conference in 2024
- Some denominational control within church law and structure
- Bishop and Cabinet still have input and direction for pastoral selection

NON-DENOMINATIONAL INDEPENDENT

Pro

- No Trust Clause church owns property
- No conference apportionme
- No interference from denominational leaders
- Free to create our own identity
- Give us time to determine our long-term affiliation options
- Gives time to GMC to congeal, aiding in better evaluation
- Church will be congregational polity rather than episcopal (bishop-led) polity

Con

- Must develop our own statement of beliefs (our own theology) prior to selecting our own pastor
- Must find and vet our own pastor and provide insurance, pension and housing
- Must develop our own governance structure and develop our own membership requirements
- Must develop our own accountability policy and structure
- Must create our own connections to other like-minded churches
- Need strong, consistent, biblically grounded lay leadership to keep the church from drifting
- No outside support from a denomination
- Without proper oversight deviation from the teachings of the bible may mislead members
- Unfamiliar territory for our church
- Organizational & theological uncertainty for a much longer period
- Internal conflicts lead to confusion with no outside support
- Will require a substantial investment of resources (time & money)
- Mistakes in developing all the above will be made

Human Sexuality	Matches 2016 UMC Book of Discipline with statement that "all people are of sacred worth; fidelity in marriage and celibacy in singleness; clergy cannot conduct same-sex marriage and LGBTQIA+ cannot be ordained, however self-avowed non-practicing homosexuals can be ordained as clergy	Guiding practices and theology around issues of human sexuality would need to be established by the church
Future disaffiliation options	Quick, simple, and without cost	Not an issue since an independent church is not affiliated with a denomination
